# Minutes of The Arc, Upper Valley Annual Meeting held on Thursday, November 7, 2018, Muddy Rivers Ballroom, Grand Forks, ND

#### **Brief Order of Business:**

The Treasurer's Report is based on the previous year's Independent Accountants' Compilation Report. The Board of Directors accepted the 2018 Independent Accountants' Compilation Report completed by Brady Martz.

Total revenues were \$521731, a decrease of 17% from 2017. 71 volunteers contributed an additional \$50,860 to our programs and business operations in 2018 through their volunteer efforts.

Total expenses were \$694,924, a decrease of less than 1% from 2017.

Secretary Fugazzi thanked our membership and friends for their volunteer time, financial contributions and donations to our programs and stores.

## **Election of Officers and Directors:**

All members were notified that they could find a copy of the Nominating Committee's Report on the organization's website and were invited to submit additional candidates in writing. Having received no further nominations, a unanimous ballot was cast for the slate of directs and officers as presented.
